#### **PRESENTATION**

Two years after the Conference opening the Research project of national interest on the subject Criminal Law and the Treaty establishing a Constitution for Europe (Prin 2005), involving the Universities of Catania, Como-Insubria, Ferrara, Modena and Reggio Emilia, Verona, new perspectives and the need for a reflection emerge owing to the resumption of the reform process following the Lisbon Treaty of December 13<sup>th</sup>, 2007, after the negative issue of the referendums in France and Holland that had halted the ratifying process of the constitutional text of 2004. Changes of outstanding importance concern the criminal law; they are connected to the overcoming of the division into pilasters and to the enlargement of the "communitarian" method to the procedures of production of European sources: the position of the Parliament will be equivalent to that of the Council, and national Parliaments will be involved since the "ascending" phase of the legislative process, strengthening its democratic nature and its transparency as well as the respect for the principles of subsidiarity and proportion. On such basis the explicit attribution to the Union of competences in criminal matters will be aimed at the creation of that common "Area of Freedom. Security and Justice" promised to Europeans citizens as a correlative to the free circulation of individuals, goods, services and capitals in an inner marked now enlarged to 27 nations. The target is not only the fight on "common basis" against all forms of trans-national crime (terrorism, illicit trafficking, trafficking in human beings, corruption, money laundering, organized crime, computer crime), establishing "minimum rules" with regard to the definition of criminal offences, sanctions and even procedure norms – particularly on the matter of evidence, collection and circulation -, but also to ensure the effective implementation of the Union policy and the protection of its interests, starting from the financial ones. To the Conference – held with the essential cofinancemend of OLAF and the patronage of the Italian Group of AIDP- will participate well known Italian and foreigners scholars and experts together with the members of the Research Units; the interventions at the five sessions and at the final Round Table will contribute to the critical evaluation of the results obtained and to the discussion of future perspectives.
